RapidRedact Desktop release

New Feature – Reporting (Release 2.20)

RapidRedact Reports

The all-new Reporting feature allows organizations to generate reports for information redacted from documents and for users to quickly access details about documents that they have redacted themselves.

The reports contain detailed information about what has been redacted, including the type of information, how many instances of each target was found, what exemption codes were used, and on what pages the redactions occurred.

The Reporting feature benefits both organizations and users alike, by allowing them to quickly review details of redacted documents once outputted. The reports are saved along with the related Audit document or at a user-defined location and can be accessed at any time for reference purposes.

Listed below are a couple of common questions related to Reporting:

Q. How do I access the reporting feature?

A. The RapidRedact Output window has been re-designed and now includes a 'Report' area which lists a number of report types. The selected report will be generated when the redacted document output options are confirmed.

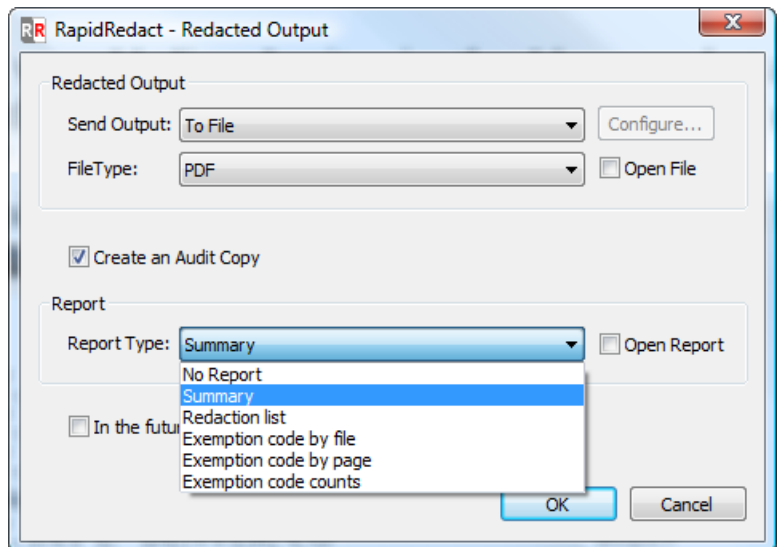
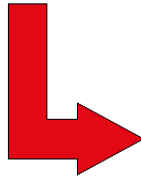
Q. I noticed that there are a number of report types, what are the differences?

A. Each report type has a unique way of organizing reported information, differences between the report types are explained in detail on page 133 of the RapidRedact user manual.

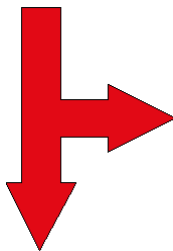
The screen-shot to the right demonstrates the changes that the RapidRedact Output dialog has undergone.

The new report section lists the five available report types that are available for Redacted documents. The report will be saved in the same location as the documents Audit copy. If no Audit Copy saved, the user will need to define the reports intended location.



Here are two examples of the reports (Summary and Exemption code by page).

These reports contain information about the same document, but the reports are structured differently and display information in reflection of the user's reporting requirements.

Upcoming Development

Listed below are just a couple of the many features we are currently working on which will be implemented into RapidRedact Desktop over the coming months.

Management of Stamps and Exemption Codes

The management feature will allow stamps and exemption codes to setup in a central location and deployed to all users at once so that stamps and exemption codes don't need to be configured individually on each computer.

Historic Reporting

Reports can now be generated for individual documents after being redacted and outputted, but what if an organization needs to quickly access reported information for a group of redacted documents?

Historic reporting will allow just that, user's will be able to access an interface listing groups of reports organized by the timeframe in which they were created. For example users will be able to view reports generated in the last day, week, month, etc without the need to locate the individually stored report for each document.

Windows 7 compatibility

The next release of RapidRedact Desktop will be fully compatible with the Windows 7 operating system.
